## **TERMS AND REGULATIONS FOR PARTICIPATION**

### **1- TERMS OF REFERENCE**

In these Terms and Regulations for Participation the term "Exhibitor" shall include all employees, staff and agents of any company, partnership, firm or individual to whom space has been allocated for the purpose of exhibiting.

The term "Exhibition" shall mean: **The Wedding Show 2007**

The term "Organiser" shall mean: **Events Unlimited**

### **2- APPLICATION FOR PARTICIPATION**

- a) All applications for participation shall be made on the prescribed **Booking Form** which shall be submitted to the Organiser. Rejection of an application by the Organiser shall not give rise to any claim for damage.
- b) The Contract between the Exhibitor and the Organiser as defined in clause 14(a) below shall come into force when the Exhibitor submits the **Booking Form**.
- c) The **Booking Form** must be completed with all the required information. By signing the **Booking Form**, the Exhibitor is deemed to have agreed to all the terms and regulations unconditionally and waives his right to contest same.

### **3- ALLOCATION OF EXHIBIT SPACE**

- a) The Organiser shall allocate the space in accordance with the nature of the exhibits or in the manner the Organiser deems fit.
- b) Should exceptional circumstances so demand, the Organiser shall reserve the right to change the space allocated to the Exhibitor at any time prior to the commencement of the Build-Up of the Exhibition. Such changes shall be at the discretion of the Organiser and the Exhibitor shall have no claim for compensation as a result of the changes.

### **4- USE OF EXHIBIT SPACE**

- a) Exhibitors are bound to exhibit the announced products or services and to have competent personnel during the opening hours of the Exhibition. Each Exhibitor shall occupy the space allotted to him **by 15:30 on 12 April 2007**. In the event of default for whatever reason, the Organiser has the right to deal with the space in any way he thinks best and in this case the exhibition deposit will not be refunded.
- b) All exhibits and products displayed must accord with the description on the Booking Form and be related to the theme of the Exhibition. Direct sale to the public is permissible. If the nature of the products do not conform with the theme of the event, the Organiser can remove the exhibits or order the dismantling of the booth.
- c) Exhibitors are not allowed to sub-let the space allotted to them to other parties either in whole or in part without the written consent of the Organiser. Modifications, including decoration such as painting the floor, ceiling and pillars are not permitted, and consequent damage to the Exhibition hall shall be compensated by the Exhibitor.
- d) Exhibitors shall be totally responsible for the cost of restoring, to its original condition, any part of the hall or structure occupied by them, which has been altered or damaged in any way.
- e) Exhibitors shall be totally responsible for obtaining visas as may be required to enable them, their staff, agents, representatives, visitors, or others to attend the Exhibition. In no event shall there be any claim for damages or otherwise against the Organiser in respect of any loss or expense relating thereto.

### **5- TERMS AND METHODS OF PAYMENT**

- a) 50% deposit of the participation fee and or relevant stand charges must be paid upon signing the Booking Form by the Exhibitor.
- b) The full participation fee shall be paid no later than **31 March 2007**. Otherwise, the Organiser has the right to cancel the contract or re-rent the space, and in either case, the exhibition deposit will not be refunded.

### **6- DECORATION OF STANDS**

- a) All Exhibitors must complete their construction and/or decoration of their stands no later than **9:00 pm on Wednesday 11 April 2007**.
- b) The Organiser reserves the right to make an additional charge to each Exhibitor equal to any amount charged to the Organiser for any delays and/or services supplied whether specifically ordered or not. The Organiser accepts no responsibility to breakdown or failure of any of the services provided for or in connection with the Exhibition.

### **7- MOVEMENT OF EXHIBITS**

Exhibitors shall remove all exhibits from the Exhibition Hall no later than **9:00 pm on Sunday 15 April 2007** and shall indemnify the Organiser for loss by reason of delay or damage to the Exhibition Hall. Any material, exhibits or equipment left on site after this time will be disposed of.

### **8- SECURITY**

- a) The Organiser shall take all the reasonable security precautions in the interest of Exhibitors and Visitors.
- b) The Organiser shall not be held responsible for any loss or theft or damage to exhibits at the exhibition halls during the Build-Up and Dismantling periods. The Organiser shall also not be held responsible for any loss or damage to exhibits or any articles belonging to the Exhibitor.

### **9- INSURANCE**

The Organiser is not responsible for any damage caused by the Exhibitors to a third party or to themselves, nor to the loss, theft or destruction of equipment or commercial goods exhibited. Each Exhibitor must subscribe to an individual insurance policy against these risks.

### **10- FIRE REGULATIONS**

- a) Materials used in stand and display construction must be properly fire-protected in accordance with Jordanian regulations.
- b) The Organiser has the right, should circumstances so require, to make changes to the Exhibitor's stand for the purpose of fire prevention and control.

### **11- BREACH OF CONTRACT AND WITHDRAWAL BY EXHIBITOR**

- a) In the events of abandonment or rejection by the Exhibitor of the allocated space(s), the Organiser has the right to cancel the Exhibitor's application. In this case, the Exhibition deposit will not be refunded.
- b) In the event of partial abandonment or rejection by the Exhibitor of the allocated space, the Organiser has the right to cancel the application or re-allocate the partly abandoned or rejected space. In this case if the participation fee for the diminished space was already paid, the deposit will not be refunded. But if that fee was not paid yet, the Exhibitor should pay half of the fee related to the diminished space.

### **12- CHANGES OF DATES OR CANCELLATION OF EXHIBITION**

- a) The Organiser reserves the right to terminate the exhibition if use or occupancy of the Exhibition premises is or will be materially interfered with by reason of fire, casualty, strike, embargo, injunction, acts of God, terrorism, or any other act or event not the fault of the Organiser during any period of time the availability of which is critical to the successful production of the Exhibition. It is expressly agreed that such a termination shall not constitute a breach of this agreement.
- b) If unforeseen events arise which are not the responsibility of the Organiser, the Organiser reserves the right to:
  - Cancel the Exhibition: in this case the participation fee will not be refunded.
  - Change the date of the Exhibition: in this case the Exhibitors who are unable to attend the Exhibition at the new date are authorized to cancel their contract by registered letter within one week following their notification of the change of date and in this case, the Organiser will keep 50% of the participation fee.
- c) The Organiser reserves the right to change the venue and duration of the Exhibition if exceptional circumstances demand. No refunds will be given.
- d) The Organiser reserves the right to refuse admittance to the Exhibition to any person.

### **13- SUPPLEMENTARY CLAUSES**

- a) Whenever necessary the Organiser shall have the right to issue supplementary regulations in addition to those contained herein i.e. in "the Terms and Regulations for Participation" to ensure the smooth management of the Exhibition.
- b) Any additional written regulation/instruction shall be binding on the Exhibitors.
- c) The Exhibitor shall also observe the Exhibition's "General Regulations" in the "Exhibitor Manual" which will be sent to each Exhibitor containing detailed instructions for the organisation of the Exhibition.
- d) Capitalized terms shall have the meaning assigned to them in The Wedding Show "General Regulations".

### **14- DISPUTES, JURISDICTIONS AND GOVERNING LAW**

- a) The Terms and Regulations for Participation as well as the General Regulations in the Exhibitor Manual both constitute the Contract between the Organiser and the Exhibitor.
- b) The Organiser shall be deemed to be validly notified of any claim by the Exhibitor only if submitted in writing to the address given on the former page within two weeks of the closing date of the Exhibition.
- c) All disputes and/or claims arising from or pertaining to the Contract shall be settled by the competent Court in Jordan in accordance with Jordanian laws.
